

## **Glance Mmedia Technologies Pvt Ltd Terms and Conditions for use of the Website**

Glance Mmedia Technologies Pvt Ltd, whose registered office is F4 A, DDA Flats, Munirka, Delhi ("**Company**"), is the owner of the website www.thaglance.in ("**Website**") and the Glance app on the Google Play Store ("**app**") and herein after shall be referred to as "**Glance**" or 'us' or 'we'. As a user ("**User**") of this Site, the User understands that Glance is an online platform providing news and other relevant information to our users in multiple languages.

Your use of this Website implies that you have read, understood and agreed to abide by following, disclaimer, terms & conditions ("**Terms & Conditions**").
